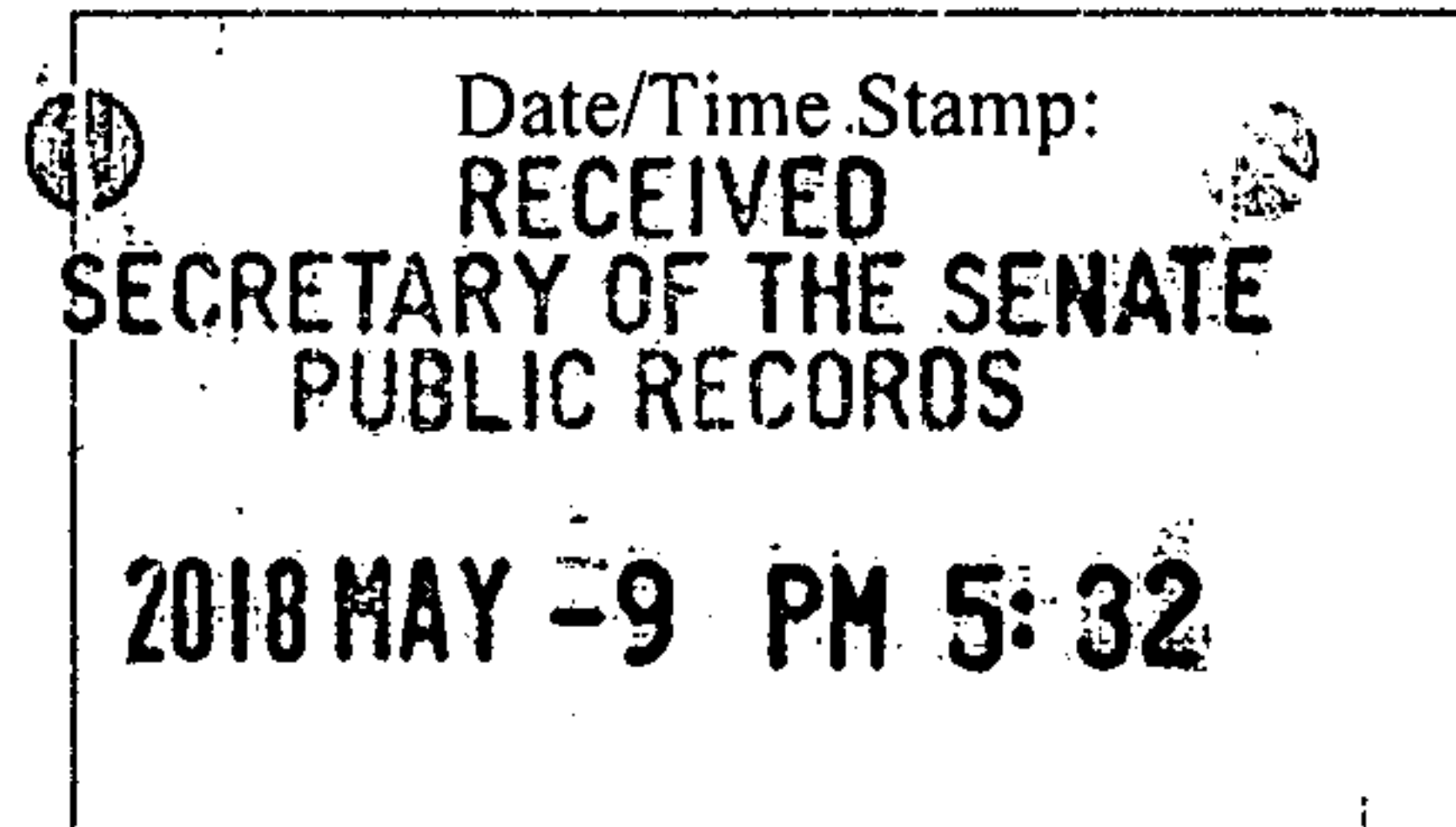

Article 1 Section 1 of the U.S. Constitution states, “All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.” The creation of this legislative body marked a significant departure from past governance systems and the start of the “American experiment.” 230 years later, how do the foundations of the U.S. government inform and influence the role of Congress today – and the responsibilities and expectations of those who serve within? In this seminar, we will examine classic and modern texts on leadership, the creation of the American democracy, and the role of Congress.

Basil Smikle



Basil Smikle Jr. is a Distinguished Lecturer in Politics and Public Policy at the City University of New York’s Murphy Institute, and a Democratic Strategist whose commentary has been regularly featured on CNN, MSNBC, Fox News, and in TheHill.com where he is a contributor. Basil was most recently the Executive Director of the New York Democratic Party during which time he was the “second highest-ranking Democrat” in the State. A PhD candidate at

Teachers College at Columbia University concentrating in Education and Politics, he is also an adjunct lecturer at Columbia’s School of International and Public Affairs.

Recognized as a staunch advocate for public service and education equity, he is part of the next generation of thinkers and policy advocates. Basil was featured in the L.A. Times as “Harlem’s New Political Elite” and gained national attention for his reforms in education and government. A profile in the Wall Street Journal led to a feature in a New York Magazine cover story on the next generation of African American leaders. The New York Daily News called Basil a “fresh thinking...school reformer”. The New York Post “enthusiastically” said “New York needs such vibrant leadership”. As a senior aide to Hillary Rodham Clinton during her first campaign for Senate and later on her Senate staff. Mrs. Clinton called Basil a “key advisor and tremendous public servant...who makes sure all voices are heard” A life-long New Yorker and raised in the Bronx by Jamaican immigrants, Basil graduated with a Bachelor of Science from Cornell University in Industrial and Labor Relations and received a Master of Public Administration degree from Columbia University’s School of International and Public Affairs.

Ron Christie



Ron Christie, founder and President of Christie Strategies LLC, is a veteran senior advisor of both the White House and the Congress, brings years of government relations and media experience. Previously, Christie served as Vice President of Navigators Global LLC - a strategic consulting and communications firm. He previously served as Executive Vice President and Director of Global Government Affairs at Ruder Finn and Of Counsel at the Washington D.C. law firm Patton Boggs, LLP. From 2002 to 2004, he was Acting Director of USA Freedom Corps and special assistant to President George W. Bush. He began service at the White House in 2001 as deputy assistant to Vice President Cheney for domestic policy, advising the Vice President on policy initiatives in healthcare, budget, tax and other policy areas.

Prior to joining the Vice President's staff, he briefly served as counsel to U.S. Senator George Allen (R-VA). He previously served as a senior advisor to former House Budget Committee Chairman and current Ohio Governor John Kasich from 1992-1999.

Christie served as a Resident Fellow at the Institute of Politics at the John F. Kennedy School of Government at Harvard University for the Fall 2011 term. He was appointed as an Adjunct Professor at the McCourt School of Public Policy at Georgetown University in 2014. He also teaches The Business of Lobbying at Georgetown's McDonough School of Business. He was appointed last year to the advisory board of the Georgetown University Institute of Politics. <http://bit.ly/1IXe68o>

Additionally he has also served as a Visiting Assistant Professor at Haverford College as well as an adjunct professor at The George Washington University's Graduate School of Political Management and was a visiting assistant professor of Political Science at Haverford College in 2009 and 2011. He has also served as a guest lecturer at University of Virginia's Center for Politics.

His first book *Black in the White House* was published on January 3, 2006 by Thomas Nelson/Nelson Current Books. His next book, *Acting White: The Curious History of a Racial Slur*, was published by St. Martin's Press/Thomas Dunne Books on October 12, 2010.

Christie published his third book entitled *Blackwards: How Black Leadership is Returning America to the Days of Separate But Equal* (St. Martin's Press/Thomas Dunne Books) on September 4, 2012. This provocative title examines whether in the euphoria surrounding Barack Obama's historic election America ushered in a new "Post-Racial" era or whether black leaders worked against this goal by pursuing an agenda of separatism and special rights that harms, rather than brings us together as American citizens.

A knowledgeable voice on American politics, Christie served as a political commentator for BBC Worldwide Television for their global 2012 election night coverage. He reprised this role to cover the 2014 midterm election coverage for BBC and will do so for the 2016 presidential election.
