



- ## Wednesday, May 30

1. Meetings with Harm Reduction International  
*The delegation heard from several experts at Harm Reduction International, the leading non-governmental organization working to promote harm reduction. Head of advocacy for HRI Fionnuala Murphy gave a presentation on the “10 by 20” campaign, an initiative to have governments redirect 10% of the resources currently spent on ineffective punitive responses to drugs and invest it in harm reduction by 2020. The delegation also discussed the promise and potential limitations of harm reduction in a global context.*
2. Meetings with DrugScience  
*The delegation met with David Nutt, founder of DrugScience and several of his colleagues. DrugScience is an independent, science-led nonprofit on drugs research, which brings together leading drugs experts to carry out original research into drug harms and effects. Discussions focused on scientific analysis surrounding relative risks of various drugs, appropriate regulation of drugs, drug testing and the need for more scientific research on drugs.*
3. Reception at the House of Lords



*The delegation attended a reception which featured informal presentations from Steve Rolles, Founder of Transform Drug Policy Foundation; Carrie Wade, R Street; and David Badcock, CEO DrugScience. Presenters discussed their organization's priorities and activities in the harm reduction space.*

#### **Thursday, May 31**

1. Meeting with Peter Hajek, Wolfson Institute of Preventive Medicine  
*Peter Hajek is Director of Tobacco Dependence Research Unit at the Wolfson Institute of Preventive Medicine. His presentation focused on the science surrounding the relative risk of various nicotine products.*
2. Meeting with Sarah Jakes and Gerry Stimson, New Nicotine Alliance UK  
*New Nicotine Alliance is a UK-based non-profit group that promotes and supports tobacco harm reduction. Presentations focused on the history of e-cigarettes and tobacco harm reduction as well as the consumer perspective for tobacco harm reduction and role of flavors.*
3. Meeting with Christopher Russell, Centre for Substance Use Research  
*CSUR is a research agency studying substance use and abuse using qualitative and quantitative methods. Dr. Russell discussed research on e-cigarette use patterns in both the UK and US.*

#### **Friday, June 1**

1. Meetings with City of London officials at Guildhall  
*The delegation met with several civil servants who focused primarily on the criminal justice angle of harm reduction. They heard from Commander Simon Bray who handles drug issues for the Metropolitan Police Service; Adam Winstock, who runs the Global Drug Survey and provides drug treatment to prison populations), and David Mackintosh, the Director and Policy Adviser for the London Drug and Alcohol Policy Forum. The meetings were followed by a reception in Guildhall.*
