On behalf of the American Israel Education Foundation (AIEF), we would like to invite you to participate in an educational seminar in Israel for Senate and House foreign policy staff, July 27-August 4, 2019. The trip will depart Saturday afternoon, July 27; and return to the U.S. on Sunday morning, August 4.
