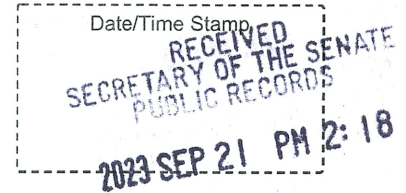

We were unable to visit Jubbet ad-Dhib on Wednesday 6/28 due to schedule switches. Other than these two changes, although specific dates and times of programming changed slightly due to the scheduling of Israeli and Palestinian leaders, the components of the programming stayed the same. Sen. Lujan had to leave a day early in order to attend the funeral of a close friend.
